

**Columbia Sheep Breeders Association

1. **CALL TO ORDER:** President, Sara Hildebrandt called the CSBA Board meeting to order at 7:00 PM, CST using a conference call format.

Jake has accepted our invitation to judge the All-American Show in Louisville, Ky. No action was needed since this was approved during the 2.27.17 Board meeting.

b. Futurity Rules

The following clarification of the Futurity Rules was moved by Sara Hildebrandt. The motion was seconded and passed by unanimous approval.

- 1) Two Junior Members are allowed to show a Comeback Futurity Yearling Ewe. One Junior member must be the owner of the ewe. The owner must be actively engaged in showing the ewe, either by holding the head or setting the feet and legs.
- 2) 22 Comeback ewes are entered for the 2017 Comeback Show. There are 30 Junior members. The Comeback Class will be split in two, dependent on the age of the ewe. If a Junior member has two ewes to show; the oldest ewe will be in Class 1 and the youngest in Class 2. The top 6 of each class will return for the final payback lineup.

8. NEW BUSINESS -- none

a. On-Line Futurity Sales

- 1) The Board will do more research on how to handle the logistics of verifying the nominated ewe lamb's information. Members are invited to submit Futurity nominated sale for Board approval.

b. Ohio Sale Futurity Nominations

- 1) A request has been made to allow Ohio nominated ewe lambs to show at the NSS. Entries for the National Junior Show are due May 1. Both of the Ohio Sales are after May 1.
